





ESR (Economic Substance Regulations)

Compliance and notification / annual return filing

On 30 April 2019, the government of the United Arab Emirates (UAE) issued Economic Substance Regulations ("the Regulations") pursuant to the Ministers Resolution No. 31 of 2019. The UAE government then issued Ministerial Decision No. 215 of 2019 providing guidance on the application of the regulations on September 11, 2019. Information regarding Regulatory Authorities responsible for administering Relevant Activities was provided in Cabinet Resolution No. 58 of 2019 which was issued on September 4, 2019.

The Regulations require businesses registered in the UAE that conduct one or more "Relevant Activities" to demonstrate adequate and appropriate economic substance in the UAE relative to the activities they undertake. Businesses that are licensed by the relevant licensing authority to carry out a Relevant Activity within the UAE will be referred to as "Licensees" in the regulations.

The Regulations had been introduced by the UAE government to honor its commitment as a member of the OECD inclusive framework on Base Erosion and Profit Shifting (BEPS) and in response to an assessment of the UAE's tax reporting framework by the European Union ("EU") Code of Conduct Group on Business Taxation.

The majority of the businesses are confused about whether their business falls in the relevant categories or not and fair enough to say they are not guided properly.


Liquidation

When a Company ceases its operations, all the assets of the company are distributed to the Shareholders of the Company after settlement of dues to creditors and lenders. However, there is much more to the process of liquidating a Company. The regulations are in place to ensure all parties involved are treated fairly – that one party does not benefit at the expense of others involved.

There are several reasons for a liquidation audit. Anytime a liquidation of Company is called for irrespective of the reason it is important that all the Company's assets are accounted for. It is just as important to discover and list all of the Company's obligations. A liquidation audit report will list the assets and liabilities of the Company and should preclude any objections from creditors. As the liquidation progresses, all the Company's assets are converted to cash and distributed to the creditors or assigned to other Company obligations. There are specific rules concerning the way the assets are distributed. It is extremely important that all the relevant information is available to Push Digits Chartered Accountants as the liquidator. Our liquidation audit helps assure the information is accurate and complete.

Liquidation audit performed by us is required before any company can be closed in UAE or any of the Free Zones in UAE. Dubai Economic Department (DED), Jebel Ali Free Zone Authority (JAFZA), Dubai Airport Free Zone Authority (DAFZA), Dubai Multi Commodities Center (DMCC) and Dubai Silicon Oasis (DSO) all require liquidation audit in their respective authority regions whenever a Company is closing its operations and cancelling its license. Abu Dhabi, Sharjah, Hamriyah Free Zone and SAIF Zone also have regulations concerning Company liquidation and for liquidation audit very similar to other regions within UAE.
